1 — PARTIES & PURPOSE

3 — TRIAL FEE & PAYMENT

4 — CREDIT TOWARD THE MAIN BOOKING

If the Client proceeds to book the Artist for the main booking within [your credit window] of the trial, the full trial fee will be credited toward that booking's total. If the Client does not proceed within that time, the credit is forfeited and no refund is issued.

5 — CLIENT PREPARATION

- Arrive ready to begin. If any preparation is needed beforehand, the Artist will confirm it with you in advance.
- Bring 3–5 inspiration images (Pinterest board, Instagram screenshots, or printed photos).
- If the session involves hair or makeup, wear a button-front or loose-neck top so the finished result is not disturbed when changing.

- Disclose any known allergies, sensitivities, or recent treatments before the session begins. The Artist is not liable for reactions to professional-grade products where the relevant information was not disclosed in advance.

6 — DOCUMENTATION & FEEDBACK

At the end of the trial, the Artist will photograph the result and document the exact products, selections, and techniques used — ensuring the result can be precisely recreated on the day.

The Client is encouraged to live with the result for several hours and provide feedback within **48 hours**. Any requested changes will be noted and incorporated into the plan for the day.

7 — PHOTOGRAPHY & PORTFOLIO CONSENT

With the Client's consent, the Artist may photograph the completed trial result for use in their professional portfolio, website, and social media. The Client will be credited by first name only.

8 — CANCELLATION OF TRIAL

- **More than 48 hours notice:** Trial may be rescheduled once at no charge, subject to Artist availability.
- **Less than 48 hours notice:** The full trial fee is charged.
- **No-show:** The full trial fee is charged. No rescheduling credit is offered.

9 — SETUP & HEALTH

The Client must provide a clean table or flat surface, comfortable chair, good natural lighting, and access to an electrical outlet. Services will not be performed if the Client has a visible infection, contagious illness, or open wound in the area being worked on.
